Suspect in Officer Involved Shooting Sentenced to 35 Years in Prison

**** UPDATE** - On Tuesday, October 31, 2023, Bronson Anderson also known as Bronson Lindsey pleaded guilty to the following charges and was sentenced to 35 years in prison:**

- Attempted Murder – Police Officer (2 Counts)**
- Robbery 1st Degree**
- Receiving Stolen Property (Firearm)**
- Convicted Felon in Possession of a Handgun**

****UPDATE** - Officer Jacob Chesher has been identified as the victim in the assault by Bronson T. Lindsey. Officer Chesher was released from the Hospital on May 15th, 2022. He sustained injuries that require healing before returning to active duty. A timeline for his full recovery is unknown.**

He has served the Owensboro community for approximately 2 years. Officer Chesher and our Department would like to thank the community for the concern, support and assistance in identifying Mr. Lindsey quickly.

The overwhelming Law Enforcement support from so many agencies in the area to assist in locating and taking Lindsey into custody does not go unnoticed. Officers and Deputies from multiple agencies responded to this massive manhunt to assist and their dedication to taking a dangerous and violent offender into custody has made our community and the surrounding communities a safer place.

****UPDATE** - With the aid of numerous tips, detectives were able to identify the suspect in this case as Bronson T. Lindsey (32 years old of Rockport, IN). An arrest warrant was**

obtained for Mr. Lindsey while agencies continued to search the Spencer County area where he was last seen.

At approximately 5:12 a.m. on May 15th, 2022, he was located in Spencer County by agencies assisting in the search. Based on the arrest warrant that was obtained, he is being held pending extradition in the Spencer County Jail.

The charges for Mr. Lindsey are listed below.

- Robbery 1st Degree
- Assault 1st Degree (Police Officer)
- Wanton Endangerment 1st Degree (Police Officer)
- Possession of a Handgun by a Convicted Felon
- Theft by Unlawful Taking of an Automobile \$10,000 less than \$1,000,000
- Receiving Stolen Property (Firearm)

On Saturday, May 14th, 2022 at approximately 8:54 pm, officers from the Owensboro Police Department were investigating a suspicious person at 1816 Triplett Street (Eagles Convenience Store). This individual and his vehicle matched the description from an earlier reported robbery at 217 E. 25th Street (Franey's Food Mart).

During questioning, the suspect began a physical altercation with officers. During the altercation, the suspect fired 1 round from a handgun he had concealed. An officer was struck. The suspect immediately stole an Owensboro Police Department police vehicle belonging to the officer and fled the scene.

The officer was transported to Owensboro Health Regional Hospital by AMR ambulance and is believed to have non-life-threatening injuries.

The stolen Owensboro Police Department police vehicle was recovered a short time later in Spencer County, Indiana.

Numerous law enforcement agencies are assisting in the search for this suspect, including the Spencer County Sheriff's Office, Indiana State Police, Jasper Police Department, and Santa Claus Police Department.

The suspect shown below is considered armed and dangerous, do not approach and notify local Law Enforcement. Anyone with additional information is asked to call OPD at 270-687-8888, or leave an anonymous tip with Crime Stoppers at 270-687-8484.
